BINDING RULES FOR USE OF THE STUDENT COMPUTER ROOM SITUATED IN THE HALLS OF RESIDENCE OF TBU IN ZLÍN

1. The student computer room (hereinafter referred to as "computer room") is intended to be used only by students who have concluded an Accommodation Contract with the TBU Halls of Residence, and that only for study-related purposes.
2. Only students accommodated in the Residence Halls are authorized to enter the computer rooms, after presenting their valid student ID card or ISIC card and entering their name, time of arrival and departure and the number of the assigned PC in the computer room visitors' book and signing in at the reception desk.
3. While they stay in the computer room, the students leave their student ID card or ISIC card at the reception desk. A student has the right to use only that computer the number of which he has been assigned.
4. By signing in (in the visitors' book) the visitors confirm that they assume personal responsibility for damage to the equipment of the computer room and are liable to HRR for dealing with the consequences arisen from misuse of computing facilities and/or from violating the following valid directives and decrees issued by TBU: Rector's Directive "*Rules for Computer Network Use at TBU in Zlín*" as amended, Rector's Directive "*Rules for Computer Network Use in the Residence Halls of TBU in Zlín*" as amended, Rector's Directive "*Rules for Connection of Mobile Devices to the Network of TBU in Zlín*" as amended and Rector's Decree "*Observance of the Copyright Act*" as amended or these "*Binding rules for use of the student computer room situated in the Halls of Residence of TBU in Zlín*" as amended. The above-mentioned directives and decrees are available on the TBU website (www.utb.cz) and posted in the computer room. Visitors using the computer room are required to acquaint themselves with the above-mentioned rules before switching on a computer.
5. Food or drink are not permitted in the computer room; it is not allowed to bring in things which could threaten the services provided in the computer room or the visitors thereof; smoking, using mobile phones and disturbing other visitors is strictly banned. Furthermore, it is not allowed to change the pre-set hardware and software configuration of all computing facilities including cabling and all peripheral units located in the computer room in any way.
6. The computer room is open between 7:00 and 22:00 every day. The computer room may be closed due to maintenance of computing facilities or due to other serious reasons. Those interested in using the computer room outside the opening hours have to pay CZK 100 per each commenced hour.
