

## **CONSENT TO THE PROCESSING OF PERSONAL DATA**

Tomas Bata University in Zlín, a public university established by Act No. 404/2000 Coll., on the establishment of Tomas Bata University in Zlín, ID: 70883521, with a registered office at T. G. Masaryka Square 5555, 760 01 Zlín, mailbox ID ahqi9id (hereinafter referred to as “TBU”) as a controller of personal data, treats your personal data as your very own property. To enable TBU to use your personal data listed below that is recorded in the IS / STAG Information System, as well as the ISKaM information system (Halls of Residence and Refectory), and to not require the completion of complicated forms for registering at the TBU halls of residence, and to continue enjoying the same benefits as other TBU students staying at the TBU halls of residence, it is necessary for you to give consent to the processing of your personal data.

1) Personal data to be processed:

- Name, surname, address of residence, date of birth, study status, university e-mail address, student identification number (i.e. the number on the card listed in STAG), faculty, type of study, year.

2) The personal data is processed for the following purpose:

- Exclusively the transfer (utilization) of personal data from the IS/STAG Information System to the ISKaM Information System.

3) Period of processing personal data:

- Consent is granted on a one-off basis for a single purpose, with corresponding period of time required for processing (transferring) said personal data. I acknowledge that the personal data transferred to the ISKaM Information System under my consent will be further processed within this system on the basis of legal titles set forth in the Privacy Policy – The Processing of Personal Data of Users of Services of the Halls of Residence and Refectory, which are available on the TBU website under the section for Privacy Policy. I also acknowledge that I can withdraw such consent at any time. I acknowledge that in such a case, I shall have to re-enter my personal data listed above in the relevant registration form of the Halls of

Residence and Refectory, and I shall no longer receive benefits that other TBU students enjoy (concessionary prices, etc.).

- as the processor of personal data, the company which provides operation and management of the ISKaM Information System, ApS Brno s.r.o., ID: 00543535, with a registered office in Božetěchova 2, Brno, has access to the personal data listed above;
- the data subject has the right to withdraw his/her consent to processing their personal data at any time, as well as other rights specified in the Privacy Policy – The Processing of Personal Data of Users of the Services of the Halls of Residence and Refectory.
